- iv. The Airport Manager discussed the Fire that occurred at the airport 26 July 2020. The fire resulted from a tenant conducting welding in his hanger which caught adjacent material on fire. Mr. Bell (tenant) is currently in Vanderbilt Hospital. Gallatin Fire Department (GFD) responded to the fire. The incident brought to light the need for greater coordination and planning between MCEA and the GFD.
- V. GFD will revisit the Airport Response Committee, putting in place a fire grid, and additional GFD training.
- vi. The Airport Manager discussed the fact that he has received several inquiries regarding opportunities to build hangers at MCEA. This fact indicates that MCEA has a bright future for growth.
- vii. The Airport Manager will be on vacation 28-31 July 2020.
- The AC is scheduled to review the 2020 Budget and develop the Airport Managers Operating Budget August 3, 2020.
