- 3. Ms. Casey made a motion to approval the Agenda as amended. Mr. Slawek second the motion. MCEAA approved unanimously.
- 4. Recognition of the public, limited to five (5) minutes on agenda items only.
- 5. Mr. Drayton made a motion to approve the minutes of the February 27, 2025 MCEAA Meeting. Mr. Alvarez seconded the motion. MCEAA approved unanimously with the exception of Mr. Jouvence who abstained.
- 6. Mr. Jouvence made a motion to amend minimum rate for hangar land leases to \$2.50 sq/ft, no second to the motion.
- 7. Mr. Drayton made a motion to set \$1.85 per sq. ft. as the minimum acceptable annual rate for hangar land leases. Mr. Alvarez seconded the motion. MCEAA approved unanimously with the exception of Mr. Jouvence who voted No.
- 8. Mr. Drayton made a motion to approve the land lease amending language to accommodate the 10-year market-rate lease adjustments and change wording of "Impact Fee." Mr. Jouvence seconded the motion. MCEAA approved unanimously.

- 9. Mr. Jouvence made a motion to suspend the rules. Ms. Casey seconded the motion. MCEAA approved unanimously.
- 10. Mr. Glover made a motion to re-instate the rules. Mr. Drayton seconded the motion. MCEAA approved unanimously.
- 11. Mr. Drayton made a motion to approve the Terminal Ramp Change Order (Garver Work Order Amendment No. 3). Ms. Casey seconded the motion. MCEAA approved unanimously.
- 12. Ms. Casey made a motion to allow Chairman to sign new T-Hangar leases. Mr. Sheppard seconded the motion. MCEAA approved unanimously.
- 13. Ms. Alvarez made a motion to adjourn the meeting. Mr. Brinson seconded the motion. MCEAA approved unanimously. The meeting was adjourned at 7:25pm.
