- 3. Mr. Drayton made a motion to approval the Agenda as amended, adding the HVAC proposals for Hangers A-2 and A-3. Mr. Slawek second the motion. MCEAA approved unanimously.
- 4. Recognition of the public, limited to five (5) minutes. Dwane Ferguson and Roger Richardson spoke.
- 5. Mr. Alvarez made a motion to approve the minutes of the March 17, 2025 MCEAA Meeting. Ms. Casey seconded the motion. MCEAA approved unanimously with the exception of Mr. Abbott, who abstained.
- Ms. Casey made a motion to award HVAC contract to replace HVAC in Hangar A-2 to LMC in the amount of \$11,538. Mr. Slawek seconded the motion. MCEAA approved unanimously.
- 7. Ms. Drayton made a motion to award HVAC contract to replace heating unit in Hangar A-3 to LMC in the amount of \$12,821. Mr. Alvarez seconded the motion. MCEAA approved unanimously.

- 8. Mr. Drayton made a motion to amend FBO operational control areas. Mr. Alvarez seconded the motion MCEAA approved unanimously.
- 9. Mr. Abbott made a motion to establish an additional run-up area on the northeast corner of the northwest apron. Mr. Brinson seconded the motion. MCEAA approved unanimously.
- 10. Mr. Glover made a motion to establish a land lease renewal rate of \$1.85/sq ft annually for new and expired land leases for corporate and Port-A-Port hangars. Corporate hangars will have a 10-year renewal term and Port-A-Port hangars will have a 5-year renewal term. Mr. Alvarez seconded the motion. MCEAA approved unanimously with the exception of Mr. Abbott and Mr. Drayton, who abstained.
- 11. Ms. Drayton made a motion to adjourn the meeting. Mr. Abbott seconded the motion. MCEAA approved unanimously. The meeting was adjourned at 6:56pm.
